PROVISIONS

3. WRHC and WRHZ are licensed by the FCC as a non-commercial LPFM broadcasters, and as such will comply with all FCC regulations appropriate to such licensing.
4. Underwriters of WRHC and WRHZ do not have authority to exercise any control over the programming or policies of WRHC and WRHZ, shared programs of WRHC and WRHZ, live remote broadcasting or any other content.
5. Radio Harbor Country reserves the right to decline underwriting to businesses, organizations, and individuals for any reason.
6. Radio Harbor Country reserves the right to edit underwriting text to insure compliance with FCC regulations.
7. Programs may have more than one underwriter. WRHC and WRHZ will make every effort to insure against businesses of the same type underwriting the same broadcast hour.
8. Underwriting fees are due at the signing of this agreement. If fees are not received before the renewal date, it will result in cancellation of this agreement and on-air mentions associated with same.
